

WADE COLLEGE HEALTH AGREEMENT AND AFFIDAVIT

Beginning June 1, 2020, and until further notice by Wade College, Wade College requires all new and returning students who are voluntarily choosing to physically visit the Wade College campus to read and acknowledge receipt of the following **Wade College Health Agreement and Affidavit**.

By signing this document, you are stating that you understand all the declarations, policies, rules, and/or notices stated therein.

HEALTH DECLARATION

By visiting and/or utilizing the Wade College Campus, you are explicitly and/or implicitly acknowledging and consenting to this Wade College Health Declaration.

Wade College Policy

If you are experiencing any of the symptoms or circumstances identified in the Health Declaration, cancel your visit to the Wade College Campus and stay home. You will also not be permitted to visit and/or use the campus facilities if Wade College determines at its discretion that you are exhibiting symptoms of COVID-19.

Prior to visiting and/or utilizing the Wade College campus at any time and for any reason, you consent and acknowledge that:

- 1) In the past 14 days, you have not tested positive for COVID-19.
- 2) In the past three days, you have not experienced any symptoms of COVID-19 or been directly exposed to someone who has been diagnosed with COVID-19 or is experiencing any symptoms of COVID-19. These symptoms include:
 - Lost sense of taste or smell
 - Feeling unwell
 - Loss of appetite (skipped meals)
 - Increased fatigue
 - Coughing
 - Fever of 100.0°F or higher
 - Nasal congestion or sore throat
 - Body aches or chills
 - Shortness of breath or tightness in the chest
 - Diarrhea or abdominal pain
 - Headache
- 3) Your temperature may be taken upon your arrival, and you agree that if your temperature reads higher than 100.4 degrees Fahrenheit, subject to local guidance, you will leave the Wade College Campus and agree not to return until you have been fever-free, and otherwise not had symptoms consistent with COVID-19 infection, for 3 days. You acknowledge that information will be collected and used as described in the **Wade College Privacy and COVID-19 Notice**.
- 4) While on the Wade College campus, you agree to abide by **Wade College Campus Rules** and any other applicable Wade College campus rules that may be instituted subsequent to the acknowledgement of this document.
- 5) **You understand that despite any precautions that you, others, and/or Wade College may take, you may still be exposed to COVID-19 or individuals who have COVID-19, and you voluntarily assume that risk.**

WADE COLLEGE RULES

Social Distancing

Physical distancing of at least 6 feet between students and staff is always required. Please respect floor markings and any other visual cues that facilitate distancing on campus.

Personal Protection Equipment (PPE)

Please always wear a mask while you are on the Wade College Campus. If you must remove the mask, try to avoid touching the front of the mask as the outside might be contaminated. After replacing the mask on your face, please be sure to wash your hands.

Temperature Checks

Touch-free temperature checks will be required upon each entry into the Wade College Campus. Per CDC guidelines, individuals with a body temperature greater than 100.4 degrees Fahrenheit, or local guidelines, will not be permitted entry into campus for 3 days from the time of reading. Wade College may, at its discretion, offer to retest your temperature any time.

Prevention

Hand sanitizer is required upon entry into campus. Regular use is encouraged throughout your visit using the dispensers provided by Wade College. Wash your hands frequently for at least 20 seconds. Be sure to cover coughs, and sneeze with a tissue or inside your elbow.

WADE COLLEGE PRIVACY AND COVID-19 NOTICE

In an effort to keep the Wade College community safe in light of the COVID-19 pandemic, we are collecting additional information from our students, employees, guests, and other college visitors. Our transparency is key to maintaining your trust, and during these unprecedented times, we are especially mindful of striking the right balance between ensuring the health and safety of our students, employees, guests, and other college visitors and respecting your privacy. Accordingly, effective as of June 1, 2020, the following privacy notice (the "Privacy Notice") shall apply in addition to our existing FERPA Policy, which will continue to otherwise govern our collection, use, and other processing of your information.

As the current circumstances and the needs of our community evolve, this Privacy Notice may be modified or updated at Wade College's sole discretion. If we make any changes to our Privacy Notice, we will provide the revised document and such changes will be effective immediately upon that posting. Please review this Privacy Notice periodically to ensure you are aware of any changes.

What Information We Are Collecting

We may collect certain information about your potential exposure to COVID-19 and health through periodic health declarations or questionnaires we ask you to complete. We may also collect measurements of your body temperature when you are at campus. We will not record or store your body temperature measurement, but if your body temperature registers higher than our permitted threshold for campus access, we reserve the right to record and indicate in our system that you were denied entrance and are not eligible to return for 3 days. In addition, we may collect information provided by you, or a public health authority, or other government agency, if you test positive for COVID-19, including information about how you interacted with Wade College during the time in which you may have been infected with COVID-19. All the foregoing is referred to in this Privacy Notice as "Screening Information".

What We Are Doing with Screening Information

We collect and use Screening Information to help provide a safe environment for our students, employees, guests, and other college visitors, and to administer your enrollment and access to our campus. We will use Screening Information in furtherance of those legitimate interests and educational purposes. We will not use your Screening Information for any marketing or promotional purposes.

How We May Share Screening Information

While we generally will not share your Screening Information without your consent, we reserve the right to disclose this information, and other related information, to government and regulatory authorities, such as the Centers for Disease Control and Prevention and state and local health authorities, or as otherwise necessary or appropriate in furtherance of public health or safety. If we are notified that you tested positive for COVID-19 within 14 days after your last visit to campus, or if we otherwise determine that you may pose a risk to our community, we reserve the right to disclose to our students, employees, guests, and other college visitors that an individual who tested positive, or otherwise poses a risk to our community, was in our facilities and while we will not disclose your name unless legally required to do so, we may disclose information such as the date and time of your visit, your gender, and campus areas you used. We share this information to help ensure our campus remain safe for our students, employees, guests, and other college visitors. We may also share your Screening Information and other related information with service providers, advisors, or consultants who are performing services on our behalf and for other reasons in accordance with applicable laws, and we may disclose aggregated, de-identified information for any other lawful purpose.

WADE COLLEGE HEALTH AGREEMENT AND AFFIDAVIT

How We Retain Screening Information

Your Screening Information will be protected as described in our FERPA Policy, and will be retained only as long as we determine reasonably necessary to ensure the health and safety for our students, employees, guests, and other college visitors and in accordance with applicable laws. As noted above, your body temperature measurement will not be stored unless required by applicable law, but we will retain your acknowledgement of the health declaration, as well as any records (if any) that you were denied entrance and not permitted to return for 3 days. Any information that we retain will be stored for a reasonable period of time, including as we determine necessary to comply with applicable laws or to establish or defend our legal rights.

YOUR OPTIONS

At this time, Wade College requires you to agree to this **WADE COLLEGE HEALTH AGREEMENT AND AFFIDAVIT** as a condition of entry onto the Wade College campus. However, if you are uncomfortable with providing any requested information and/or do not wish to consent to this **WADE COLLEGE HEALTH AGREEMENT AND AFFIDAVIT**, you may still register and attend courses offered online only; by doing such, you are stating you have no intention of physically accessing the Wade College campus.
